Other refunds are at the discretion of the Hunt Test Committee. After closing time refunds will be less \$5.00 to cover administrative expenses.
- Entry fees include: \$.50 AKC recording fee, \$3.00 AKC Event Service Fee, and \$1.00 admission fee (required by the state of Iowa) per entered dog. Admission fee for non-participants is \$1.00 per day.

Our Judges will be Randy Caspel and Cheryl Clark from Ogden, Iowa.

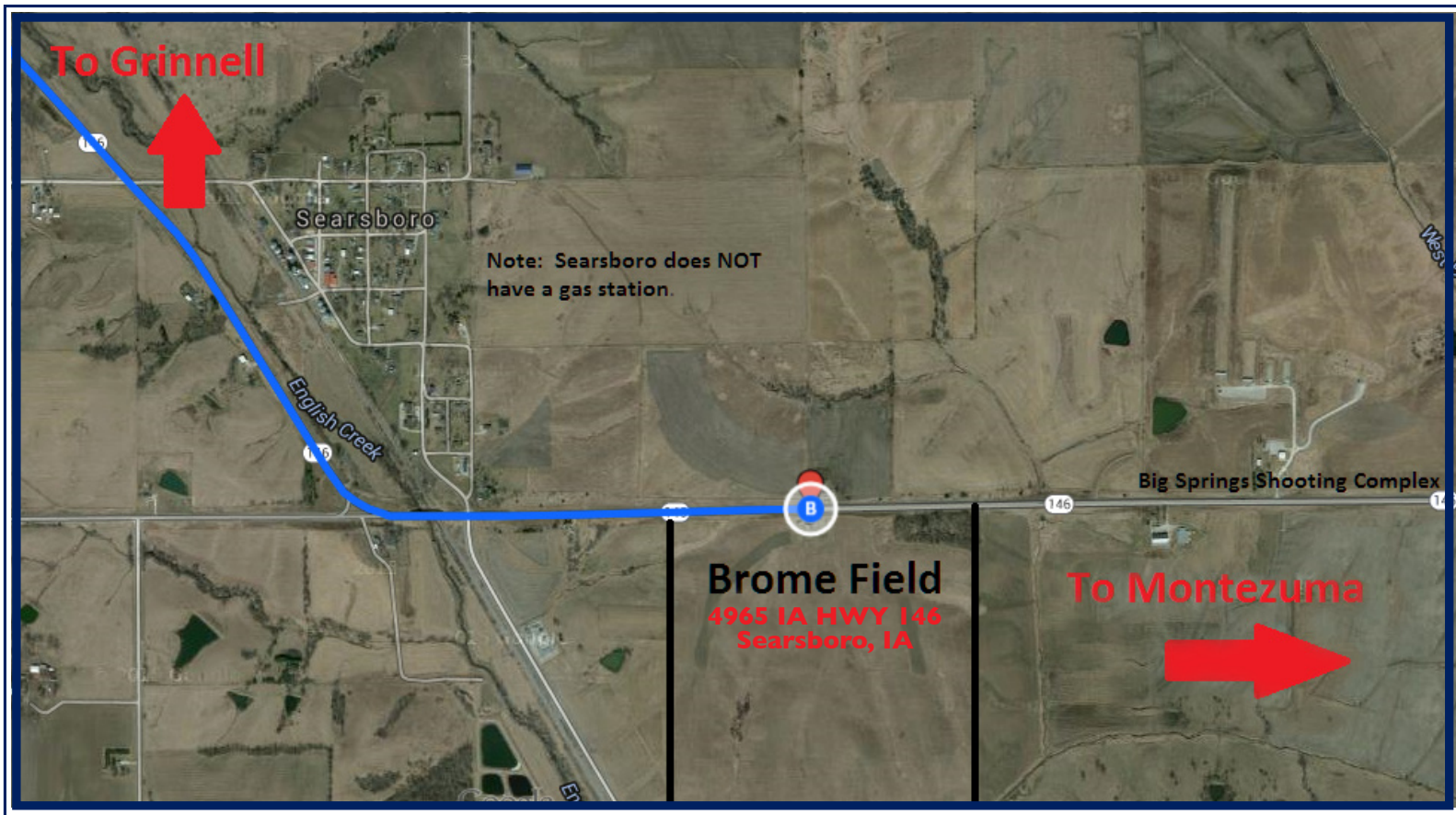

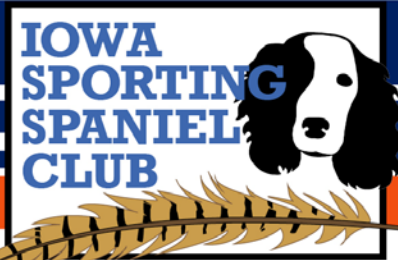
There will be no overnight camping allowed at the grounds. There is an RV campground within 10 miles of the grounds.
