Things to know...

- Refund Policy: Entry fees will be refunded for A) female withdrawn due to coming in season, B) for a dog withdrawn because of an injury, illness, or death (A veterinary certificate is required for all health related refunds.) or C) An entry that is canceled before closing. Other refunds are at the discretion of the Hunt Test Committee. After closing time, refunds will be less \$5.00 to cover administrative expenses.
- Entry fees include: \$.50 AKC recording fee, \$3.00 AKC Event Service Fee, and \$1.00 admission fee (required by the state of Iowa) per entered dog. Admission fee for non-participants is \$1.00 per day.

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
